Call to Order – Chair Sanders called the meeting to order at 3:00 p.m.

Introductions – Chair Sanders called for any introductions. None were requested.

Amendments to Agenda - Chair Sanders inquired if there were any changes to the Agenda. Curt Blair requested the following changes: deletion of Dixie Partington's presentation (it will be placed on the January agenda), under New Business Blair requested that a \$500 grant request be placed for discussion; Friedman requested that the Apalachicola Chamber request for \$600 for Walking Tour brochure printing be placed under New Business. Administrative Report

<u>Collections</u> –Blair commented on the record breaking collections for the 2010-11 fiscal year – revenue is up 6%+. <u>Financial reports</u> – Blair requested the board to review the Final FY reports and the new fiscal year-to-date report for October through Nov 30, 2011.

BP Report- Blair reported that the Media Buy 3 had been approved by BP.

2011-12 Media Budget - item not presented for review

Change Order #5 – Helen Spohrer, agent for BP funding, indicated that Change Order #5 had been approved by BP. This C.O. #5 simply transfers \$40,000 from Traditional Marketing/Online Banner Ads, over to Traditional Marketing/Internet Marketing. The change is based on favorable results of internet activities; the change does not affect any approved Media Buy Schedules.

BP Promotions Report – Helen Spohrer updated the Board with current successes and future activities. The geocache contest has been a phenomenal success and 100 additional serialed coins have been ordered. Ms. Spohrer read a letter from a geocache participant from Georgia who had never been here but came to Franklin County as a direct result of the geocache contest. The tourist was so impressed with the county, he wrote "any future vacation plans will always include Franklin County."

Ms. Spohrer distributed the "Lonely Plant" international travel publication with impressive coverage of Apalachicola and Franklin County. The cost to participate was only \$700.

Ms. Spohrer conveyed information that BP\$ will be used to host the five Visit Florida Welcome Centers directors and staff in March 2012. Visit Florida requested they be invited to visit Franklin County so they could become more informed about this area and pass that information to visiting tourists at each center. Sheila Hauser is managing the event.

Ms. Spohrer indicated that Media Buy 4 is in draft form at this time and will include major advertising in anticipation of Spring and Summer tourism. The top 10 list of TDC website hits are currently Florida, Georgia, Tennessee, Alabama, Texas, Ohio, New York, Indiana, Illinois and California; top page hits are beaches, places to stay, events, and rentals.

Debbie Geiger and Shari Hubbard were present to discuss the spring press tour.

Shari Hubbard requested that a date be set so they could begin preparations for the tour. She suggested April 18-22, 2012.

Ms. Hubbard distributed the most recent quarterly publications report with the Board. There have been 78 articles to date for 2010-11 and she indicated on page 24 is a list of anticipated articles that will soon be published.
