Call to Order – TDC Co-Chair Hosford called the meeting to order at 3:00 p.m.

#### **Administrative Report**

Financial Reports – Blair confirmed that the Board had received the financial reports via email. Local Collection of Bed Tax – Blair reviewed the current tax collections as a successful increase and up 30% from the comparable month last year.

Visit Florida Grant Processes – Cindy Clark, Bay Media, requested board direction as to submitting a Visit Florida \$5,000 Cultural Heritage Grant to secure county historical photographs, and a Visit Florida \$2500 matching grant for advertising Motion to proceed with Visit Florida grant submittals:

#### Marketing:

BP Media Buy Schedule 4 update – Helen Spohrer distributed Change Order 7 which awards \$37,500 split equally to the three Visitor Centers, as requested by the FCBOCC, and if approved by the FCTDC Board, Spohrer will submit the Change Order to BP on Friday, 2/17/12. Ms. Spohrer explained that the Board of Commissioners failed to approve the Geiger tour for April and instead directed the funds be allocated to the three Visitor Centers for media press tours. Elaine

Rosenthal, Executive Director of the SGI Visitors Center, suggested that the action was "late to do" because it did not give enough time to establish a press tour.

Motion to approve Change Order 7 as presented: Motion Allen, 2<sup>nd</sup> Cook, passed

Collins motioned that the remaining TDC funded Geiger Press Tour be scheduled for September 26-30, 2012: Motion: Collins, 2<sup>nd</sup>, Prickett, passed

Ms. Spohrer also updated the board about scheduled events and other information relating to MB4:

A day-long Seafood Media Day is scheduled for March 21; this event is a mini press tour with local and regional media participating. It is expected that BP representatives will also attend.

The TV program "Fishing the Flats" will begin the 2<sup>nd</sup> week in April to film on April 9, 10, 11 in all three areas of the county.

The TV PBS public broadcast Plein Air Travel will begin filming in April county wide – filming crew will include three-minute videos in area specific locations throughout the county.

Springtime in Tallahassee is scheduled for March 31, 2012

The 15 managers from the five Florida Welcome Centers will be visiting Franklin County on April 24-27, 2012 and will be split as 5 managers per each area specific.

The \$5,400 allocation for Photography will be split as \$1,800 for each of the three Visitor Centers The Board of Commissioners directed the TDC to hire a photographer for Franklin County - – each Visitor Center must compose a "shot list" for their area by March 1, 2012 and forward to Helen Spohrer.

Motion to approve \$5,400 split out as directed by the BOCC and presented by Ms. Spohrer; Motion: Collins, 2<sup>nd</sup> Friedman, passed
