Call to Order – Vice Chair Alice Collins called the meeting to order at 3:02 p.m.

Introductions – Vice Chair Collins recognized the audience.

**Amendments to Agenda** – Mark Friedman requested to add an agenda item for discussion of the "Governor Stone" sailing vessel.

### **Administrative Report**

Collections - In the absence of Administrator Curt Blair, Fran Edwards reviewed the collections report to date indicating collections are up for the fiscal year by 10%.

Edwards distributed the most recent Geiger quarterly report and accompanying letter from Shari Hubbard which reviews the Scope of Work by Geiger on behalf of the FCTDC. The updated report included a new article about Apalachicola not yet in print through "Florida Travel & Life" but this article was written as a direct result of Geiger's personal coordination with the journalist. Current value of advertising equivalency is \$1,330,515.00

### **Committee Reports**

Marketing: Helen Spohrer, of Forgotten Coast TV and Agent of Record for current BP Phase 4 funding, distributed a monthly report through July 8, 2011 of promotional activities. This report includes all media relating to the current program which has been placed for Media Buy 1. She also compared the statistical data presently available of the major increases in action since the "We're Salty" campaign began and before the media plan was in place. Previous website visits as of June 18 were average 183 per day; as of July 9 there is an average of 392 visits per day.

Board discussion of additional billboard consideration was discussed for US Hwy 231 and US Hwy 331

### **Grants:**

2011-12 Small Grants - The board received the final Off Season Grants score sheet for review. Grants Committee Chair Prickett indicated that since 6 of the grants were transferred to BP for funding that 34 grants remained with a total request of nearly \$115,000. She explained that \$100,000 had been set aside for 2011-12 grants but that \$8000 will be for \$500 grants, \$72,000 was allocated for grant awards, and \$20,000 was allocated for production and marketing for the grants. However, she suggested since

we had the BP funding for major advertising, that the \$20,000 marketing allocation could be transferred back into the grant award allocation to total funds of \$92,000 for distribution. She indicated that by using the \$92,000 everyone who submitted an application could received 80% of their request, thereby no one would be left out this year. She also suggested that the 50% requirement of grant funding to be used for out of county advertising be reduced to requiring 30% requirement for out of county advertising.

Motion to transfer \$20,000 marketing allocation back into grant awards to total \$92,000 for distribution to off season grant program and recommend to the FCBOCC to award each applicant 80% of their request and to reduce the out of county advertising requirement from 50% to 30%.

Motion: Friedman, 2<sup>nd</sup> Hosford, passed

2011-12 Sustaining Grants -Chair Prickett then introduced the list of current sustaining and seed funding grant recipients and requested discussion regarding awards for sustaining grants and seed funding grants for 2011-12 year. The allocation for 2011-12 is \$100,000. Collins commented to find a source of funding for the Seed Grants. Hosford suggested it be raised to \$10,000 for Seed Grants.

Motion to approve and fund current sustaining grant recipients @ \$20,000 each; to approve and fund the two current seed grant recipients \$10,000 each; transfer \$20,000 from the Aid to Local Governments allocation into the sustaining grant program:

# **Continuing Business –**

Marketing: Helen Spohrer gave an update of activities regarding marketing approvals by the FCBOCC - Softball Tournament was very successful. Staff distributed a copy of the printed Softball Brochures that was distributed to participants.

The FCBOCC did not approve the \$27,500 allocation of BP funding to the three geographical areas. It was tabled for discussion at their meeting on July 19, 2011.

A discussion of the Visitors Center \$25,000 media allocation will be tabled to the FCTDC Committee meeting of July 28.

"Governor Stone" sailing vessel – Friedman explained that the Friends of the Governor Stone sailing vessel are requesting an allocation to bring the "Governor Stone" to Franklin County for March and April 2012. It will be docked at Riverfront Park or Ten Foot Hole Park in Apalachicola for one month for the Annual Boat Show, and in April will be moved and docked in Carrabelle for the Riverfront Festival. The Friends of the Governor Stone will be handling all the operations while in port.

Motion to allocate up to \$7,500 from BP monthly promotions for transporting costs associated with bringing the Governor Stone to Franklin County:

Helen Spohrer discussed the FCBOCC's request to fund the Florida Seafood Festival for \$45,000 out of the BP Phase 4 funds.

The Franklin County Oyster Festival was awarded \$5,000 from BP Phase 4 monthly promotions; however their event coordinators requested additional funding to make the event successful. Collins suggested that the event coordinators meet with the SGI Coalition to request that the Coalition request that the geographical split-out of BP available funding of \$27,500 be approved for the Franklin County Oyster Festival by the FCBOCC.
