Call to Order: Chair Jackel called the meeting to order at 3:00 p.m.

Introductions: Chair Jackel introduced David Butler and stated he would like to appear on the agenda.

Amendments to Agenda: David Butler was put on the agenda to speak at this time.

David Butler indicated he thought there was enough support in the county to ensure passage of a 2% tourist tax increase. He requested the TDC to discuss the matter and asked that the TDC request the FCBOCC to put the 2% increase on the referendum for a public vote.

Blair confirmed that each committee chair had received agenda items to discuss in preparation for the Committee Meeting on May 21st.

Continuing Business:

Big Bend Scenic By-ways Kiosks - Reese (TDC liaison to BBSB) reported kiosks would have GPS locations. That the kiosks will be a two year project. Locations have been set within Franklin County. A large "sit down kiosk" will be located at 4th Street in Carrabelle.

Blueways Community Program - Herzog was not present, but Blair reported the FCBOCC had executed the Proclamation that Franklin County, Florida is a "Florida Paddling Trail Blueway Community" and this designated the FCTDC as liaison to the Blueway Community.

Riverways South - Blair reported that FCTDC is a co-op with Riverway South for a travel writer tour in June.

Armory Renovation - Jackel reported on progress of the Coombs Convention Center. That bids have not advertised yet for the next phase of renovations.

Public Comments:

Themo Patriatis, Chair for the Paddle Jam Event - May 16-18, spoke to the Board to thank the TDC for the tremendous support for this event. He inquired as to the value of support from the TDC as a sponsor. Blair confirmed the event had received a \$500 grant, plus media kit and other grant advertising support, valued at approximately \$3,000. Patriatis asked if the county had mailed that check. Staff indicated it was mailed in December. Jackel requested staff contact County Finance to see if the check had cleared. Patriatis also thanked the Apalachicola Area Chamber for their assistance with the event.

Reports by Local Government Representatives:

Franklin County: Chair Jackel reported that bids for the renovation of the Eastpoint Visitors Center had been opened at the FCBOCC meeting on Tuesday, May 6; 2 companies bid the project - they were L. Thomas/Eastpoint for \$75,000, and Simple/Tallahassee for \$62,867 - the bids are under research by Alan Pierce's office. She indicated there would be change orders for removing brick facade and replacing with stucco, and adding a new roof at a cost of \$7,000.

Jackel requested the board motion to purchase five new county road signage at the entrances of Franklin County and for them to be paid from any leftover funds not used in the 2013-14 budget. Staff will review funds. Estimated cost about \$400-\$600 per sign.
