**Call to Order:** Establishing a quorum, Chair Sanders called the meeting to order at 3:00 p.m. **Introductions:** Chair Sanders requested if there were any introductions to be made. None voiced.

# **Administrative Report:**

Collections and Financial Reports – Blair confirmed with the board that members had received emailed meeting documents including the financial reports. Blair indicated that current collections indicate 14% increase for the fiscal year and that the County's detailed expense report had not been received.

Board Vacancy – Blair shared a letter from John Hosford who has indicated he must resign due to a residency issue. Chair Sanders commented she was "sad to see you go" and the board reluctantly motioned to accept his resignation and for staff to advertise the board vacancy position.

BP Grant Submittal Update – Blair advised the board that the FCTDC pending award submittal for the first round of BP Restore funding was not one of the 33 which received an award. Chair Sanders indicated "the Board is not happy that Franklin County did not receive anything." Blair is inquiring with the BP sources for information as to why Franklin County was excluded.

Florida Humanities Council – Letter of Intent Grant Application: Blair stated that the Florida Humanities Council grant had awarded \$15,000 to FCTDC upon the Letter of Intent for the project "Voices on the Forgotten Coast". Cindy Clark and staff are working on the application. It will be finished and mailed before the deadline of December 14, 2012.

# **Advertising Costs**

Gulfscapes Snowbird ad for SGI Snowbird Day – Blair explained there was an outstanding \$850 bill from Gulfscapes for advertising costs that should have been paid with the BP funds. Somehow no invoice was generated in time, and since no BP funds remain, Blair requested the pleasure of the board as to this matter. Chair Sanders questioned if there are any more of these out there.

Motion to approve payment of the \$850 from 2011-12 promotional funds and for staff to compose a letter to Forgotten Coast TV to request further details of any outstanding bills that might be rendered:

Anita Grove questioned paying for the sign with TDC funds. Alice Collins indicated to Grove that if she wished to submit costs to the board for a new approved sign, she could do so.
